As per the Affiliation-Bye-Laws", Clause 2.5 SPECIAL PROVISIONS FOR FOREIGN SCHOOLS

The following special provisions have been made in respect of the schools situated in foreign countries seeking affiliation with the Board. The special provisions are to be read in reference to the existing provisions applicable to the schools in India. The other provisions will be applicable to the foreign schools to the extent possible if not otherwise provided for.

2.5.1 No Objection Certificate (NOC) 2.5.2 The schools will submit No Objection Certificate (NOC) issued after due diligence by High Commission/Consulate/Embassy of India in the concerned country clearly stating that the school has been established within the legal and administrative framework of the respective country by an entity permitted to establish and run school in that country. The NOC shall clearly mention that the school fulfills all the conditions required for establishing and opening a school including land requirements in the respective country.

Kindly help us in receiving the NOC ASAP and let us know for any further requirements.
