**1. NAME OF THE TRUST:**

#### **4. TRUST PROPERTY:**

The Settlor hereby transfers a sum of Kz. 5 Million\_/- (Kwanzas Five Millions only) as the initial corpus of the Trust, which shall be used solely for the objectives of the Trust.

#### **5. BOARD OF TRUSTEES:**

The following persons shall be the **Founder Trustees** of the Trust:

3. Mohammad Ammar
4. Prem Tiwary

#### **6. POWERS AND DUTIES OF THE TRUSTEES:**

The Trustees shall have the following powers:

- To manage all assets and property of the Trust.
- To open and operate bank accounts.
- To accept donations, grants, gifts, and aid from individuals or organizations.
- To buy, sell, lease, or construct properties for the Trust.
- To appoint staff, teachers, administrative and support personnel.
- To make rules and regulations for the functioning of the school(s).
- To maintain proper accounts and get them audited annually.

#### **7. MEETINGS OF THE TRUST:**

- Meetings shall be held at least twice a year.
- Quorum for the meeting shall be 2/3rd of the total Trustees.
- Resolutions shall be passed by a majority vote

In the event of dissolution, all remaining assets of the Trust shall be transferred to another trust or institution with similar charitable objectives, and not distributed among the Trustees.

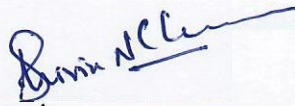
